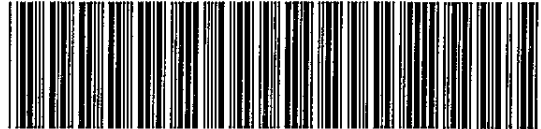

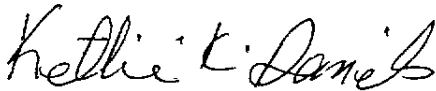

Pursuant to provision of section 607.1006 Florida statues, The undersigned Florida profit corporation Adopts the following Articles of Amendments to its articles of incorporation.

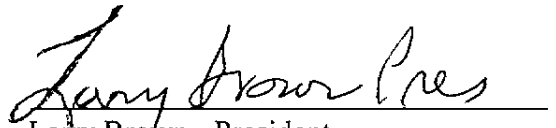
FIRST:

Article I is amended to change the name of the corporation to:

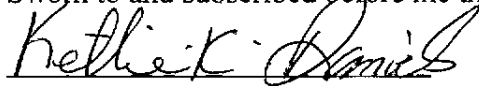
L. BROWN DETAILING INC.
