### ARTICLES OF INCORPORATION OF

### **CIMARELLI INVESTMENT CORPORATION**

WE, the undersigned, do hereby associate ourselves together and subscribe this Certificate of Incorporation for the purpose of forming a corporation under the laws of the State of Florida, and subject to the following provisions:

### **ARTICLE I**

THE name of the Corporation shall be:
