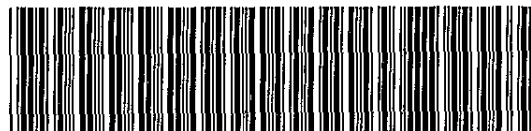

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is J & R MOTOR HOME RENTALS, INC.

ARTICLE II

The existence of the Corporation shall begin on the date that these Articles are filed.

ARTICLE III

The street address of the principal office of the Corporation is 2851 Hammondville Rd, Pompano Beach, FL 33069 and the mailing address is P.O. Box 667198, Pompano Beach, FL 33066.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 500, par value \$.01 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V

The initial street address of the Corporation's registered office is Dubow & Dubow, 215 N Federal Hwy, Dania Beach, FL 33004. The initial registered agent for the Corporation at that address is David J. Wallace, Esq.

ARTICLE VI
