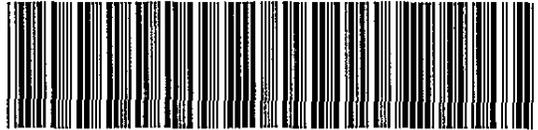

FOR

ARTICLE I - NAME

EFFECTIVE DATE  
01-01-03

The name of this Corporation shall be **Garcia, Mackin & Associates, Inc.**

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing upon *January 1, 2003*.

ARTICLE III - PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK

This Corporation is authorized to issue Two Thousand (2000) shares of \$1.00 Par Value Stock.
