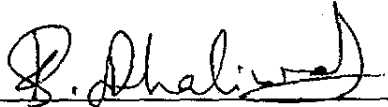
**SECOND:** ARTICLE VII is amended to state that the officer(s) and/or director(s) of the corporation are:

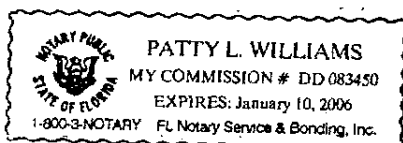

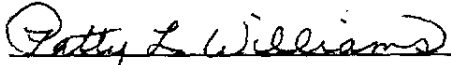
