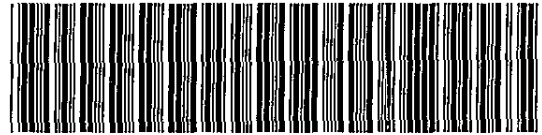

The undersigned, acting as directors for the purpose of forming a corporation under and by virtue of the laws of the State of Florida, adopt the following Articles of Incorporation.

**ARTICLE I**

The name of the corporation shall be Community Interim Bank and its initial place of business shall be 3001 Lake Mary Boulevard, Lake Mary, Florida 32746.

**ARTICLE II**

This corporation shall be organized as a successor institution in accordance with Section 658.40(4), Florida Statutes.

**ARTICLE III**

The total number of shares authorized to be issued by the corporation shall be one (1) share. Such share shall be of a single class and shall have a par value of \$1.00 per share. The corporation shall begin business with at least \$1.00 in paid-in common capital stock to be divided into one (1) share. The amount of surplus with which the corporation shall begin business shall not be less than \$9.00, all of which (capital stock and surplus) shall be paid in cash.

**ARTICLE IV**

The term for which said corporation shall exist shall be one (1) year.

**ARTICLE V**

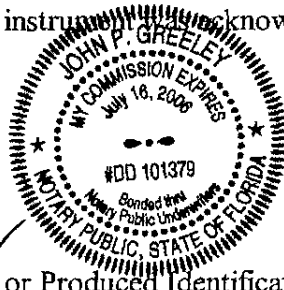


