### ARTICLES OF INCORPORATION OF

### Guzman Title Research, Inc.

#### **ARTICLE 1. - NAME**

The name of the Corporation is Guzman Title Research, Inc..

#### **ARTICLE 2. - PRINCIPAL OFFICE**

The principal office of the Corporation shall initially be at 4726 Oakley Road, North Port, Florida 34286-2353. The Corporation may change its principal office from time to time as permitted by law.

#### **ARTICLE 3. - MAILING ADDRESS**

The initial mailing address of the Corporation shall be 4726 Oakley Road, North Port, Florida 34286-2353. The Corporation may change its mailing address from time to time as permitted by law.

#### ARTICLE 4. - PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business.

The holders of the common stock of the Corporation shall have the preemptive right to purchase, upon such price, terms and conditions as shall be fixed by the Board of Directors, such of the shares of
