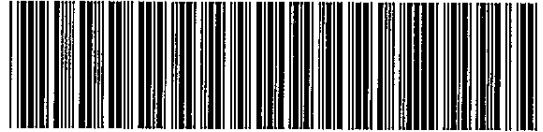

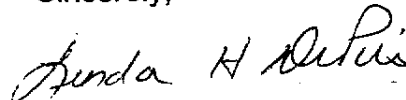

Pursuant to the provisions of Section 607.1006, Florida Statutes, **Premier Orthopedic Acquisition, Inc.**, a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: Article I is hereby amended to read as follows:

**"ARTICLE I
NAME**

The name of the corporation shall be: Premier Orthopedic & Injury Center, Inc."
