ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF AVENTURA AUTOMOTIVE, INC

The undersigned, Neil Goodman, President of Aventura Automotive, Inc. Florida corporation (the "Corporation") whose Articles of Incorporation were filed on January 13, 2003, and registered under document number P03000004383, hereby certifies:

- 1. The name of the Corporation is Aventura Automotive, Inc.
- This amendment to the Corporation's Articles of Incorporation shall amend Article V in its entirety to increase the number of authorized shares of Common Stock from Five Thousand (5,000) to Seven Thousand Eight Hundred Forty-Three (7,843), as follows:
