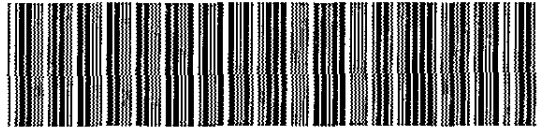



The aggregate number of shares which the corporation shall have authority to issue is one hundred (100) of ONE DOLLAR (\$1.00) PER SHARE.


ARTICLE FIVE
