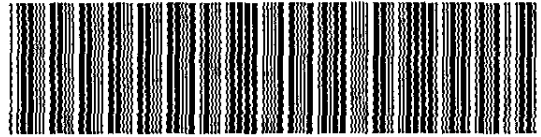

OF

ARTICLE I.

The name of this corporation is KENCON CORPORATION.

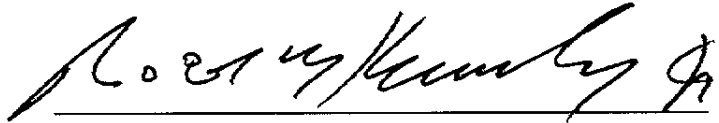
