ARTICLES OF INCORPORATION OF JOB RITE, INC.

ARTICLE I

The name of the Corporation is Job Rite, Inc.

ARTICLE IV


The total number of shares of capital stock that the Corporation shall have authority to issue is 1,000 all of which are to be common stock with a par value of \$.01 per share.
