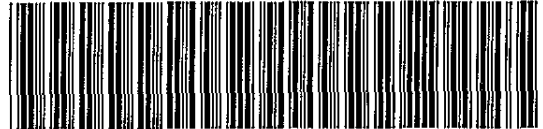



Article X Stock Distribution and Transfer

In the event of the death or incapacity of any board member/shareholder, his voting right and stock shall transfer to his estate. The corporation shall maintain a life insurance policy for each owner, with coverage amount to be determined by the FMV of the corporation, in order to execute the purchase of the stock from his estate. The FMV and life insurance policy coverage shall be re-determined and changed, if necessary, every 24 months.

Article XI Indemnification

Each officer of the corporation, whether or not then in office, shall be indemnified by the corporation against all cost and expense reasonably incurred him in connection with any claim, demand, action, suit, or proceeding in which he may be involved or be made a party to by reason of his being an officer. Said expense to include attorney fees and the cost of reasonable settlement, except when such claim, demand, action, suit, or proceeding directly relates to a negligence of the performance of his duties as officer. Right of indemnification shall inure to the benefit of the heirs, executors, and administrators of the officers.
