ARTICLES OF INCORPORATION

In compliance with Chapter 607 and/or Chapter 621, F.S. (Profit)

ARTICLE I NAME

The name of the corporation shall be:

The purpose for which the corporation is organized is:

To engage in any legal and lawful business, or service.
