ARTICLES OF INCORPORATION

OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I-NAME

The name of this corporation is SWEET WATER REALTY, INC.

ARTICLE II-DURATION

This corporation shall have a perpetual existence, commencing on January 1, 2003.

The general purposes for which the corporation is organized are:
