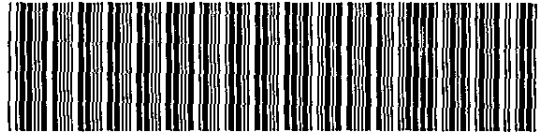

ARTICLE I: NAME

ARTICLE VII: OFFICERS AND INCORPORATORS


