

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is TORCON USA, INC.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: C/O Grant Kaplan 20283 State Road 7, #400 Boca Raton, Florida 33498

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
