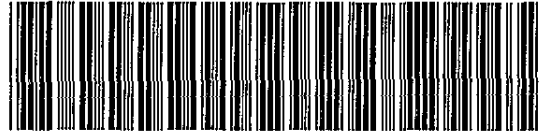

**ARTICLES OF INCORPORATION OF
PINPOINT INTERACTIVE MEDIA, INC.**

ARTICLE I – NAME

The name of this corporation is Pinpoint Interactive Media, Inc. (the "Corporation").

ARTICLE II - PRINCIPAL OFFICE


