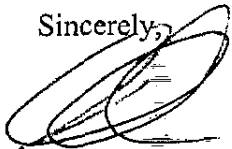

Enclosed herewith is the Articles of Amendment to the Articles of Incorporation of Ivy Advisors Corporation. These Articles were submitted to your office for filing, together with the requisite filing fee. Simultaneously, the Articles of Amendment to the Articles of Incorporation of Yale Capital Corporation were submitted, also with the requisite filing fee. Ivy Advisors Corporation was, and remains, in good standing. Yale Capital Corporation had been dissolved by the Secretary of State, even though its Annual Report and payment were submitted to your office, but rejected, as a result of lack of identification of officers. As a result of the lack of good standing of Yale Capital Corporation, the Amendment by Ivy Advisors Corporation was rejected. No link exists between the two of them, other than their desire to exchange names. Either Yale Capital Corporation can change its name, so as to permit Ivy Advisors Corporation to assume that name or the Articles of Amendment by Yale Capital Corporation may be accepted as a consent to the use of the name of a dissolved corporation. In either respect, Ivy Advisors Corporation should have been permitted to change its name to Yale Capital Corporation, irrespective of the standing of the current Yale Capital Corporation.

Please review this matter expediently and let me know if you will accept the filings as presented.

**Yale Capital Corporation**, a corporation organized and existing under the laws of the State of Florida (the "Corporation"), under the hand of its undersigned Director and pursuant to §607.1006, Florida Statutes, hereby certifies that on September 28, 2004, the Board of Directors of said Corporation signed a written statement, duly adopting and approving an amendment to the Articles of Incorporation of the Corporation by deleting Article I thereof, in its entirety, and by substituting therefor the following:

ARTICLE I - NAME

The name of this Corporation shall be:

**IVY ADVISORS CORPORATION**

This amendment shall be effective as of October 1, 2004. All other provisions of the Articles of Incorporation shall remain in full force and effect and shall not be modified hereby.
