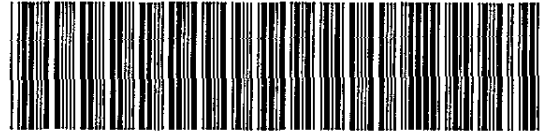

Article XIII – Amendment


