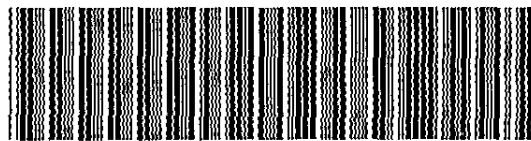



Article I - Name

The name of this corporation is TRUTHFULTEES.COM, INC. and its principal office is located at 4742 Jillian Lane, Cocoa, Florida 32926.

law.


Article XI - Amendment


