ARTICLES OF INCORPORATION
OF
PERSONALIZED ENGRAVINGS of COUNTRYSIDE, INC.

ARTICLE ONE

The name of the corporation is PERSONALIZED ENGRAVINGS of COUNTRYSIDE, Inc. and it's principal office and mailing address is 1857 Venetian Pt. Dr., Clearwater, Florida, 33755

The aggregate number of shares which the corporation shall have the authority to issue is 10,000 with the par value of one dollar (\$1.00) each.


ARTICLE FIVE

The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.


