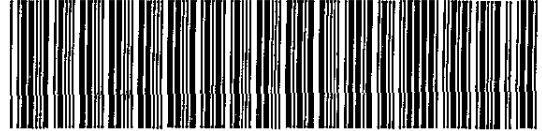

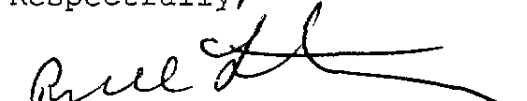

ARTICLES OF INCORPORATION
OF

SECRETARY OF STATE
TALLAHASSEE, FLORIDA

MASTER SUPPLIES, INC.

ARTICLE ONE

The name of the corporation is MASTER SUPPLIES, Inc. and it's principal office and mailing address is 1857 Venetian Pt. Dr., Clearwater, Florida, 33755

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of all lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE FOUR

The aggregate number of shares which the corporation shall have the authority to issue is 10,000 with the par value of one dollar (\$1.00) each.

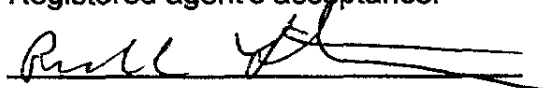
ARTICLE FIVE
