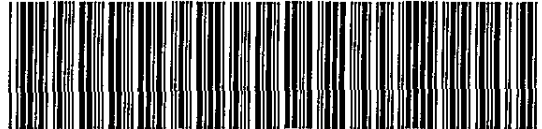

NAME AND ADDRESS

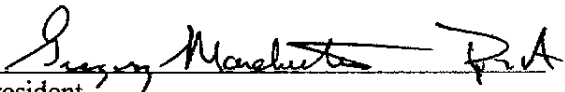
