The undersigned incorporator, for the purpose of forming a corporation in compliance with Chapter 607, and/or Chapter 621, F.S. (Profit), hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be:

ARTICLE III PURPOSE

The purposes for which the corporation is organized are:

1. For the advancement and diffusion of knowledge by teaching and research, particularly in science, humanity, and technology, and in close association with industry and commerce.
2. To confer Degrees and other academic distinctions and to grant Diplomas, Certificates or other awards on and to persons who will have pursued a course of study or educational program approved by the University and who will have passed examinations or other tests approved by the University.
3. To admit Graduates of other Universities to Degrees of equal or similar rank in the University.
4. To prescribe the disciplinary provisions to which Students of the University will be subject.
5. To provide instructions in such branches of learning as the University may think fit, with particular regard to the provision of higher education and research in the pure and applied sciences, humanities, and technologies.
6. To cooperate with other Universities and Authorities for the extension of University teaching and influence in academic matters and for such other purposes as the University may from time to time determine.
7. To do all such other acts and things whether incidental to the powers aforesaid or not as may be requisite in order to further the objects of the University.
