The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I

NAME AND ADDRESS

1. The name of this corporation is Resort Boat Rentals, Inc. and the address of the corporation is 4940 58th Ave. S., St. Petersburg, Florida 33715.

DURATION


