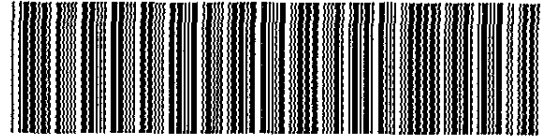



ARTICLES OF INCORPORATION
OF

The undersigned incorporator, a natural person competent to contract, hereby forms a SubChapter 'S' corporation for profit under the General Business Corporation Act and other laws of the State of Florida.

ARTICLE I - NAME OF CORPORATION

The name of this corporation is **TOVAR INTERIORS INC.**

ARTICLE II - PRINCIPAL OFFICE

The principal office and mailing address of this Corporation shall be: TOVAR INTERIORS, INC. with the mailing address of: 1030 Paces Circle, Apt 210, Apopka, FL . 32703-8602

ARTICLE III - CAPITAL STOCK

The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time is one thousand (1,000) shares of common stock having a par value of One Dollar (\$1.00) per share.

ARTICLE IV - RESTRICTIONS ON TRANSFER

Shares of the Corporation held by each Shareholder may not be sold or otherwise transferred to other persons unless first offered to this Corporation or to the remaining Shareholders in proportion to their shares. The price, terms and other provisions regarding this restriction may be specified by written agreement among the Shareholders, which agreement may expand this Article

and which may also include the Corporation as a party.

ARTICLE V - INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered office designated by the Corporation is: 1030 Paces Circle, Apt 210, Apopka, FL 32703. The name of the initial registered agent designated by the corporation at this address is: FERNANDO TOVAR. The Board of Directors may from time to time move the registered office to any other address in Florida and may designate a new registered agent.

ARTICLE VI - INCORPORATOR

The name and address of the incorporator is:

ARTICLE VII - INITIAL BOARD OF DIRECTORS

A. The initial number of Directors of this Corporation shall be one. The number of Directors may be increased or diminished from time to time by Bylaws but shall never be less than one.

B. The initial members of the Board of Directors, to hold office for the first year of existence of this Corporation, or until their successors are elected or appointed shall be:

C. Any Director may be removed from office for any cause deemed sufficient by the shareholders of the Corporation. Such removal shall be by a majority of the stock entitled to vote thereon at any annual or special meeting of the shareholders.

ARTICLE VIII - GENERAL PURPOSE AND BUSINESS

The general purpose for which this Corporation is organized shall be to conduct and transact any and all lawful business authorized or not prohibited by Chapter 607 of the Florida Statutes, as the same may be from time to time amended, including, but not limited to:

A. The furnishing, supplying and installation of dry wall, building materials and other building components to commercial businesses and corporations for a fee, and to enter into contracts and other agreements with businesses to install drywall and other building materials and other components.

B. To engage in any other lawful business or businesses as the corporation may deem desirable from time to time.

ARTICLE IX - BYLAWS

The power to adopt, amend or repeal bylaws shall be vested in the Board of Directors, subject to the power of the shareholders to repeal or amend any bylaws adopted by the Board of Directors. The shareholders also reserve the concurrent power to adopt bylaws and to prescribe in any bylaws that such bylaws shall not be amended or repealed by the Board of Directors.

ARTICLE X - TERM OF EXISTENCE

This Corporation shall have perpetual existence, commencing on the date of execution and acknowledgment of these Articles of Incorporation.

ARTICLE XI - OFFICERS

The bylaws of the Corporation shall provide for certain officers and the duties of all officers and prescribe the time and manner of their election. The initial officers of the corporation shall be:

ARTICLE XII - INDEMNIFICATION

The Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE XIII - MEETINGS

Meetings of shareholders and directors, including the time, place and manner of calling such meetings, shall be fixed by the bylaws of the Corporation.

ARTICLE XIV - ADDITIONAL CORPORATE POWERS

In furtherance hereof, and not in limitation of the general powers conferred by the laws of the State of Florida, and pursuant to the purposes and objectives hereinabove stated, this Corporation shall have all and singular the following powers:

A. To enter into, or become a partner in, any arrangement for sharing profits, joint venture or otherwise, with any person, firm or corporation to carry on any business which this Corporation has the direct or incidental authority to pursue.

B. To purchase and acquire any or all of its shares owned and held by any shareholder who should desire to sell, transfer, or otherwise dispose of his shares, or any or all of its shares owned and held by a shareholder who dies; provided, however that the capital of the Corporation

shall not be impaired thereby.


C. To enter into, for the benefit of its employees, one or more of the following:

(1) a pension plan, (2) a profit sharing plan, (3) a stock bonus plan, (4) a corporate health plan, (5) a group term life insurance plan, or (6) any other retirement or incentive compensation plan.

ARTICLE XV - AMENDMENT

The Corporation reserves the right to amend these Articles of Incorporation in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the shareholders, and approved at a shareholders' meeting by a majority of the shares of stock entitled to vote thereon, unless all the Directors and all the shareholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

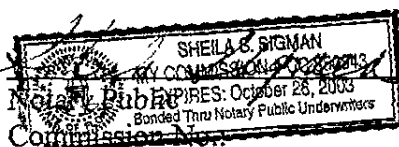




