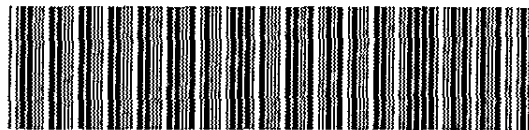



**ARTICLES OF INCORPORATION
OF
QUALITY SWIMMING MANAGEMENT, INC.**

The undersigned hereby makes, subscribes, acknowledges, and files these Articles of Incorporation for the purpose of forming a Corporation under the Laws of the State of Florida.

**ARTICLE I
NAME AND ADDRESS**

The name of the corporation shall be Quality Swimming Management, Inc. The principal place of business shall be 5601 Regency Lakes Blvd., Coconut Creek, Florida, 33073.

**ARTICLE II
DURATION**

This corporation shall exist in perpetuity.
