

ARTICLES OF INCORPORATION

OF

FREEDOM ENT., INC.



The undersigned natural person, being of legal age, does hereby subscribe for the purpose of forming and organizing a corporation for profit under the provisions of the Florida Business Corporation Act, and hereby adopts the following Articles of Incorporation covering the existence and organization of this corporation.

ARTICLE I NAME

The name of this corporation shall be Freedom ENT., INC.

ARTICLE II PRINCIPAL OFFICE

The street address of the initial principal office is 1531 S. Tamiami Trail, Suite 703, Venice, Florida 34292. The mailing address of the corporation is 1531 S. Tamiami Trail, Suite 703, Venice, Florida 34292.

ARTICLE III CAPITAL STOCK
