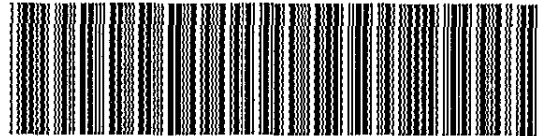

The professional service corporation shall have perpetual existence starting on the date these articles of incorporation were filed with the Florida Department of State.
