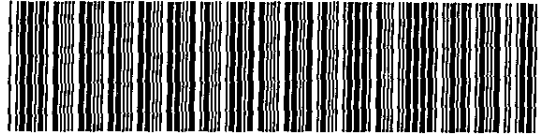

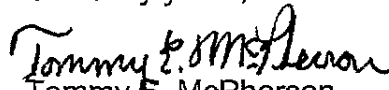

ARTICLE ONE

The name of the corporation is GATESWOOD SPORTS, INC.

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The general purposes for which the corporation is organized are:

1. To engage in the business of sales and service of sporting goods, citizen band radios, and associated equipment..
2. To transact in any other lawful business for which corporations may be incorporated under the Florida General Corporation Act.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE FOUR

The corporation is authorized to issue Sixty (60) shares of common stock without par value.

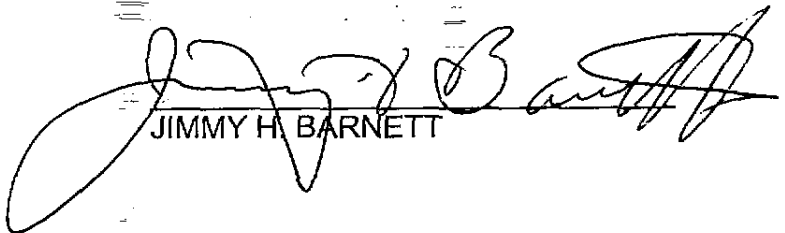
