The undersigned incorporator of these Articles of Incorporation, a natural person competent to contract, hereby forms a Corporation for profit under the laws of the State of Florida.

ARTICLE I NAME

The name of this Corporation is **BOTTOM LINE OPERATIONS, INC.**, a Florida Corporation.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is 6051 North Washington Boulevard, Sarasota, Florida, 34243.

ARTICLE III PURPOSE

The corporate purposes are:

To engage in any lawful act or activity for which corporations may be organized under the laws of the State of Florida.

ARTICLE IV SHARES

ARTICLE IX AMENDMENT


