**ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of the Corporation shall be **EAGLE EYES TILE, CORP.**

**ARTICLE - II - Existence**

The Corporation shall have perpetual existence.

The general purpose of the business to be transacted by this Corporation is:


