ARTICLES OF INCORPORATION OF

Siesta Pools, Inc.ARTICLE 1. - NAME

The name of this corporation is Siesta Pools, Inc..

ARTICLE 2. - PRINCIPAL OFFICE; MAILING ADDRESS

The principal office of the corporation is initially 1988 Wood Hollow Place, Sarasota, FL 34235 and the mailing address of the corporation is initially 1988 Wood Hollow Place, Sarasota, FL 34235. The corporation may change its principal office and/or mailing address from time to time as permitted by law.

ARTICLE 3. - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.



The undersigned incorporator has executed these Articles of Incorporation on January 16, 2003.




