ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF ESSA PROPERTIES, INC.

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Business Corporation Act, Essa Properties, Inc., a Florida corporation (the "<u>Corporation</u>"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. ARTICLE I of the Corporation's Articles of Incorporation is hereby deleted in its entirety and replaced with the following:

ARTICLE I - NAME

The name of this Corporation is: 4930 University, Inc., and the principal office and address is: 6066 St. Augustine Road, Jacksonville, FL 32217.

2. Except as amended by Section 1 above, the Articles of Incorporation of the Corporation, as amended, shall remain the same.

3. These Articles of Amendment to the Corporation's Articles of Incorporation were adopted by the directors and shareholders of the Corporation on $\frac{1}{22}$, 2016, and the number of votes cast for the Amendment was sufficient for approval.

4. These Articles of Amendment shall be effective upon filing with the Florida Department of State.
