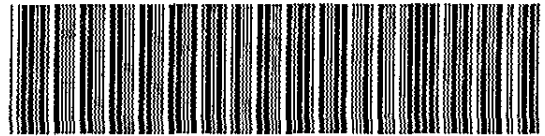

ARTICLE 1  
NAME
