

ARTICLES OF INCORPORATION OF FLORIDA AUTO CORP. OF PINELLAS

The undersigned incorporator of theses Articles of Incorporation does hereby form a corporation pursuant to the Florida General Corporations Act and does hereby adopt the following Articles of Incorporation:

ARTICLE ONE NAME AND PRINCIPAL OFFICE

The name of this corporation is FLORIDA AUTO CORP. OF PINELLAS. The corporation's principal office is located at 511 Palm Drive, Largo, FL 33770.

ARTICLE TWO DURATION

The corporation is to exist perpetually.

ARTICLE THREE PURPOSE

This corporation is organized to transact any and all lawful business for which corporations may be incorporated under the Florida General Corporations Act, including the sale of used motor vehicles.

ARTICLE FOUR CAPITAL STOCK

The aggregate number of shares which this corporation is authorized to issue is 10,000 shares of common stock, each having a par value of One Dollar (\$1.00). Once issued, all shares shall be deemed fully paid and non-assessable.
