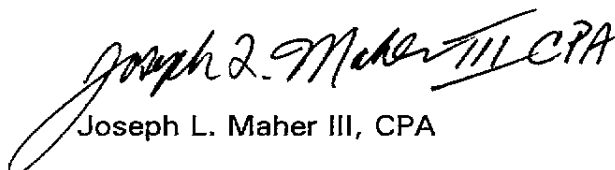

I, the undersigned, a natural person competent to contract, do hereby make, subscribe, and file these articles of Incorporation for the purpose of organizing a non profit corporation under the laws of the State of Florida.

ARTICLE I - NAME

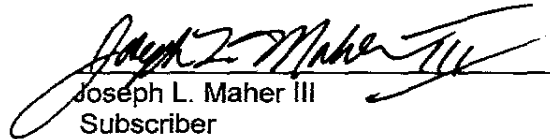
ARTICLE X - INDEMNIFICATION
