ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of the corporation is LITTLE DOLPHIN CHILD CARE, INC (bereinafter called the "Corporation").

- D. To guarantee, endorse, purchase, hold, sell, transfer mortgage, pledge or otherwise acquire or dispose of the capital stock of, or any bonds, accurities or any other evidence of indebtedness created by any other corporation of the State of Florida or any other state or government, and while owner of such stock exercise all the rights, powers and privileges of ownership, including the right to vote such stock.
