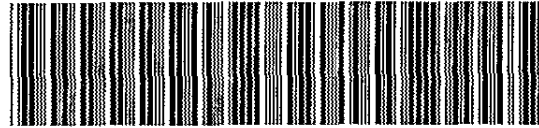

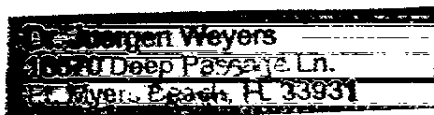

ARTICLES OF INCORPORATION

of

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE 1

NAME AND ADDRESS

Section 1.1 **Name.** The name of the corporation is Starlite Restaurant 2003, Inc..

Section 1.2 **Address of Principle Office.** The address of the principal office is 1113 Estero Blvd., Ft. Myers Beach, FL 33931.

ARTICLE 2

DURATION

Section 2.1 **Duration.** This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed, except that if they are not filed by the Department of State of Florida within five business days after they are executed, corporate existence shall commence upon filing by the Department of State.

ARTICLE 3

SHARES

Section 3.1 **Shares.** The number of shares of stock that this corporation is authorized to have outstanding at any one time is 7000 shares of voting common stock having a par value of \$ 1.00 per share.

ARTICLE 4

INITIAL REGISTERED AGENT AND STREET ADDRESS

Section 4.1 **Registered Agent.** The street address of the initial registered office of this corporation is 1113 Estero Blvd., Ft. Myers, Florida 33931, and the name of the initial registered agent of this corporation at that address is Shanon Basham.

ARTICLE 5

DIRECTORS
