We have discharged our attorney who moved and did not receive notification that this filing was required until we received the "notice of intent to dissolve."

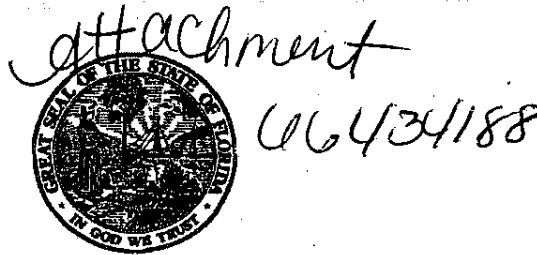
We are a small company and would very much appreciate having the late fee waived. As you can see, I have changed the name and address of current agent to myself to avoid the same problem in the future.
