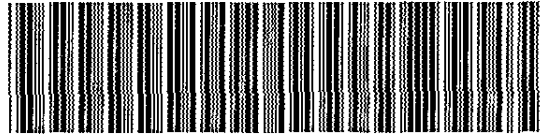

We the undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby associate themselves to form a corporation under the laws of the State of Florida

ARTICLE I

The name of this corporation is:

ARTICLE X

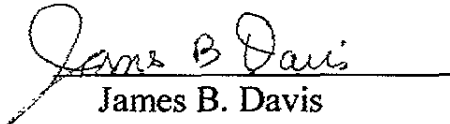
The original incorporators of this corporation shall have the right to assign and deliver their subscription of stock herein to any other persons

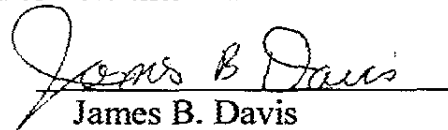
