**AMENDED AND RESTATED
ARTICLES OF INCORPORATION**

OF

**TWO TO TANGO OF JUPITER, INC.
(A Florida Profit Corporation)**

Pursuant to the provisions of Sections 607.1006 and 607.1007, Florida Statutes, this Florida Corporation adopts, duly executes and files these Amended and Restated Articles of Incorporation.

FIRST: The Florida Corporation, TWO TO TANGO OF JUPITER, INC., filed its Articles of Incorporation on January 17, 2003 and was assigned Florida Document Number P03000006703.

SECOND: The Articles of Incorporation are amended and restated as follows:

ARTICLE I

1. **Name.** The name of this corporation is TWO TO TANGO OF JUPITER, INC.

ARTICLE II

1. **Purpose and Powers.** The sole and specific purpose of this corporation company shall be to provide dance instruction services as professional dance instructors, and to engage in any other reasonably related lawful business that may be engaged in by a professional corporation organized under Chapter 607, Florida Statutes, as such business activities may be determined by the members from time to time. This corporation shall have the authority to do all things necessary or convenient to accomplish its purpose and operate its business as described in this Article.

ARTICLE III

1. **Duration.** This corporation shall have a perpetual existence unless sooner termination by agreement or law.

ARTICLE IV

1. **Authorized Shares.** The corporation shall have the authority to issue One Thousand (1,000) shares of common stock. The par value of the stock is \$1.00.
