ARTICLES OF INCORPORATION

The undersigned, duly licensed to practice medicine in the State of Florida, desiring to form a professional corporation in accordance with Chapters 621 of the Florida Statutes and the Florida Service Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I

The name of the Corporation shall be RAMESH NAYYAR, M.D., P.A.

ARTICLE II

The general purpose of the Corporation shall be any and all lawful business for which a Professional Service Corporation may be incorporated under the Laws of the State of Florida; the specific purpose of the Corporation shall be the practice of medicine and to take all actions necessary or proper in connection with that practice.

ARTICLE III

The location and address of the Corporation's initial registered & principal office in Florida is 2580 Rhode Island Avenue, Fort Pierce, Florida 34950, Saint Lucie County. The initial registered agent at the registered office is RAMESH NAYYAR, M.D.

#### ARTICLE IV

The term of existence of the Corporation is perpetual and the commencement of the corporate existence shall be at the time of the filing of these Articles.

#### ARTICLE V

The professional services of the Corporation shall be rendered only through the officer or officers who are duly licensed and legally authorized to practice medicine within the State of Florida.

#### ARTICLE VI

The number of shares of stock the Corporation is authorized to have outstanding is One Thousand (1,000) all of which are common shares without par value.

#### ARTICLE VII

The amount of capital with which the Corporation shall begin business is One Thousand Dollars (\$1,000.00).

#### ARTICLE VIII

The initial name and address of the Incorporator hereof is: RAMESH NAYYAR, M.D., 2580 Rhode Island Avenue, Fort Pierce, Florida 34950.

ARTICLE IX

The corporation shall have one director: the director for the first year shall be RAMESH NAYYAR, 2850 Rhode Island Avenue, Fort Pierce, Florida 34950, the director shall be elected annually thereafter under provisions of the By-Laws to be adopted.

ARTICLE X

This Corporation reserves the right to amend these Articles of Incorporation at any time in a manner now or subsequently permitted by statute.


