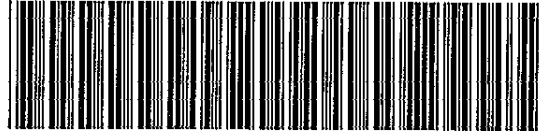

THE UNDERSIGNED SUBSCRIBER to these Articles of Incorporation hereby subscribes to and forms a corporation for profit under the laws of the State of Florida, pursuant to Chapters 607 and 621 of the Florida Statutes.

ARTICLE I - NAME

The name of the corporation is GULF DENTAL CENTER, P.A.

ARTICLE II - NATURE OF BUSINESS

This corporation is organized for the purpose of rendering professional dentistry services in accordance with the laws of the State of Florida and to engage in such other activities and endeavors as may be appropriately authorized by the corporation.
