

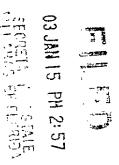

ARTICLES OF INCORPORATION

OF

Geo Emphasis, Inc.



ARTICLE I - NAME

The name of this corporation is Geo Emphasis, Inc. The address of this corporation is 6677 Cairo Road, Cocoa, Florida, 32927.

ARTICLE II - DURATION

This corporation shall exist perpetually. The date of commencement of the corporation shall be February 1, 2003.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of engaging in any business activity permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK
