ARTICLES OF INCORPORATION

OF

AV PRODUCTIONS, INC.

The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "corporation") is AV PRODUCTIONS, INC.

SECOND: The address, wherever located, of the principal office of the corporation, if known, is 950 S. Pine Island Road, Suite 150-1018, Plantation, Florida 33324.

THIRD: The mailing address, wherever located, of the corporation is PO Box 821056, South Florida, Florida 33082.

FOURTH: The number of shares that the corporation is authorized to issue is two hundred, all of which are without par value and are of the same class and are to be Common shares.
