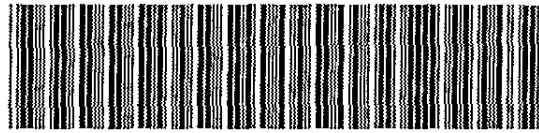

The undersigned subscriber, Maureen A. McGowan, competent to contract for the purpose of forming a corporation under the laws of the state of Florida, adopts the following Articles of Incorporation:

ARTICLE I
