ARTICLE I - NAME AND ADDRESS

The name of this corporation will be INTERNET MANAGEMENT SERVICES OF FLORIDA, INC., with its principle address and mailing address being 5030 Champion Blvd., #6-309, Boca Raton, Palm Beach County, Florida 33496.

ARTICLE II - NATURE OF BUSINESS

This corporation may engage in any activity or business for which corporations may be incorporated under Chapter 607 of Florida Statutes.

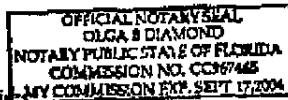
