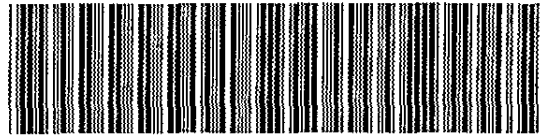

Name. The name of this Corporation is: United Surfaces International, Inc.
